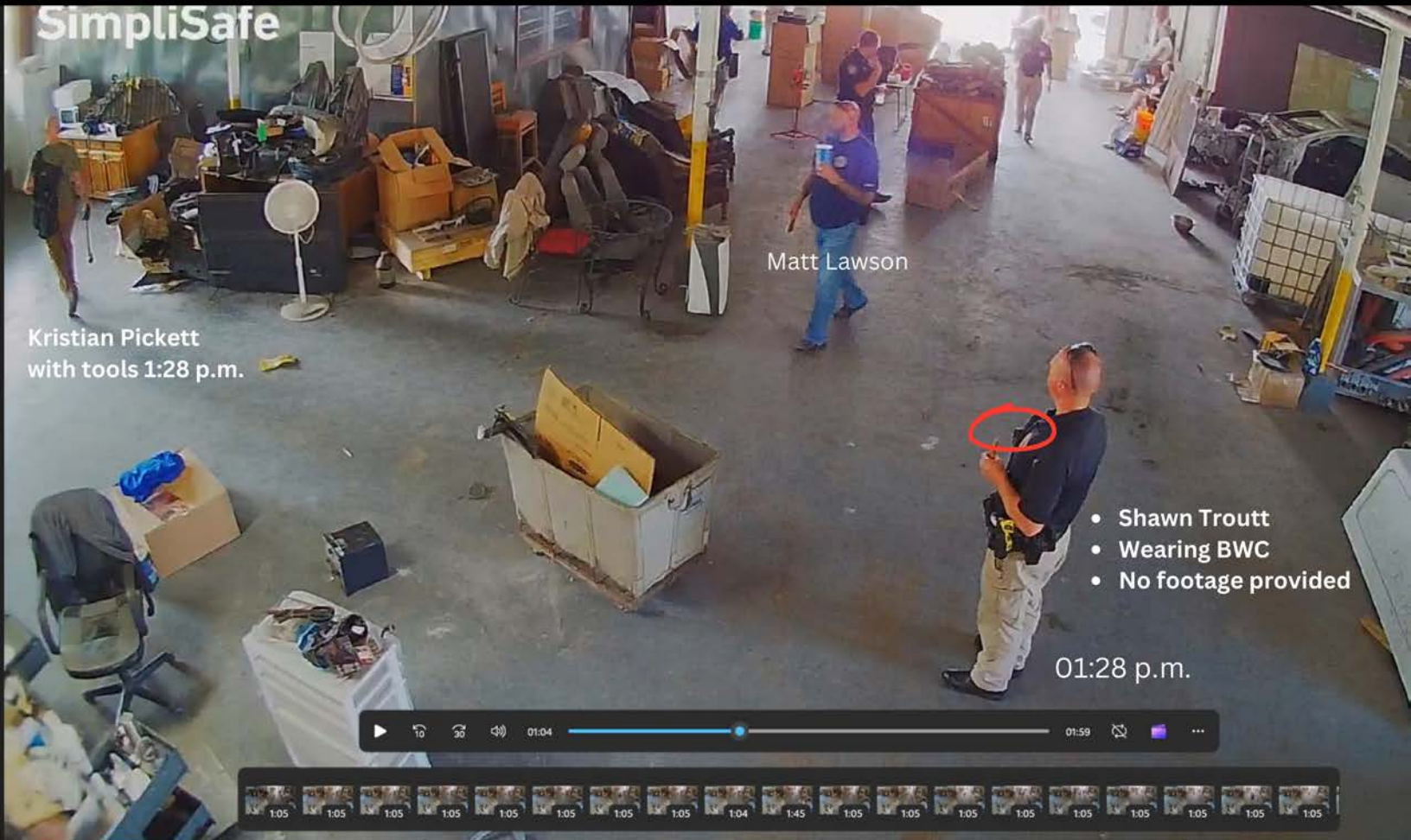

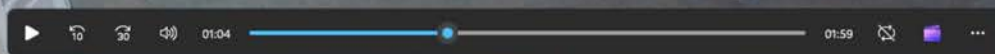

Kimberly Glenn is observed taking pictures and or video while loud metallic banging noises can be heard from the direction of the safe which is located just outside of the security camera frame. Kimberly Glenn's images were not provided in discovery despite a specific request on record that all images, including from personal devices, be provided by, and thereby agreed upon by the State to be provided by, on or before March 3rd 2023. A verbal request was later issued to the State specifically asking for Kimberly Glenn's photos. Kimberly Glenn stated that the pictures were for media only and are no longer available to provide as discovery agreed upon by the State and defense on record by order of the Court.

The following Photo of the breached safe was taken by and is provided by the defense.

No photo or video evidence of the destroyed safe was provided by the State in its discovery received by the defense.

No property receipts, nor any record of seized contents from within the safe, were provided by the State in its discovery received by the defense.

Kristian Pickett is observed examining the safe at 12:14 p.m.

Kristian Pickett along with a male in KCSO dress, whom is not named in the personnel list provided by the State, is observed between 01:28 p.m. and 01:37 p.m. with tools believed to have been used to breach the safe. There were at least 5 KCSO BWC's plus Kimberly Glenn's personal device present in close proximity during that time while many personnel looked on, including Sheriff Tom Spangler. No photo, nor video footage, was provided to the defense documenting these actions taken by the KCSO.
